A BRIEF INTRODUCTION

General Data Protection Regulation (GDPR) is the European Union's new law for individuals' data privacy & protection that will come in effect on 25th May 2018.

The GDPR specifies strict global privacy requirements primarily around how you manage and protect personal data of EU residents while respecting their choice irrespective of where data is sent, processed, or stored.

The regulation applies to all organizations that offer goods and services to people in the European Union (EU), or that collect and analyze data tied to EU residents, no matter where they are located.

KEY TENETS

STRENGTHEN PRIVACY RIGHTS OF INDIVIDUALS

The users must have the right to:

- Access their PII data
- Rectify inaccuracies in their data
- Delete their data
- Restrict or object to processing of their data
- Move their data

AUGMENT DATA PROTECTION LIABILITY & REPORTING

The companies that process individuals' personal data must:

- Enforce additional measures to ensure security, integrity & confidentiality of data
- Give clear purpose of data collection & processing
- Limit the collection & storage of data
- Obtain consent for processing data
- Report any incident of data breaches to concerned authorities within 72 hours
- Keep logs that contain data processing details

HIGH NON-COMPLIANCE PENALTY

Failure to meet GDPR requirements may lead to fine of:

- €20m
or
- 4% of annual global turnover, whichever is greater

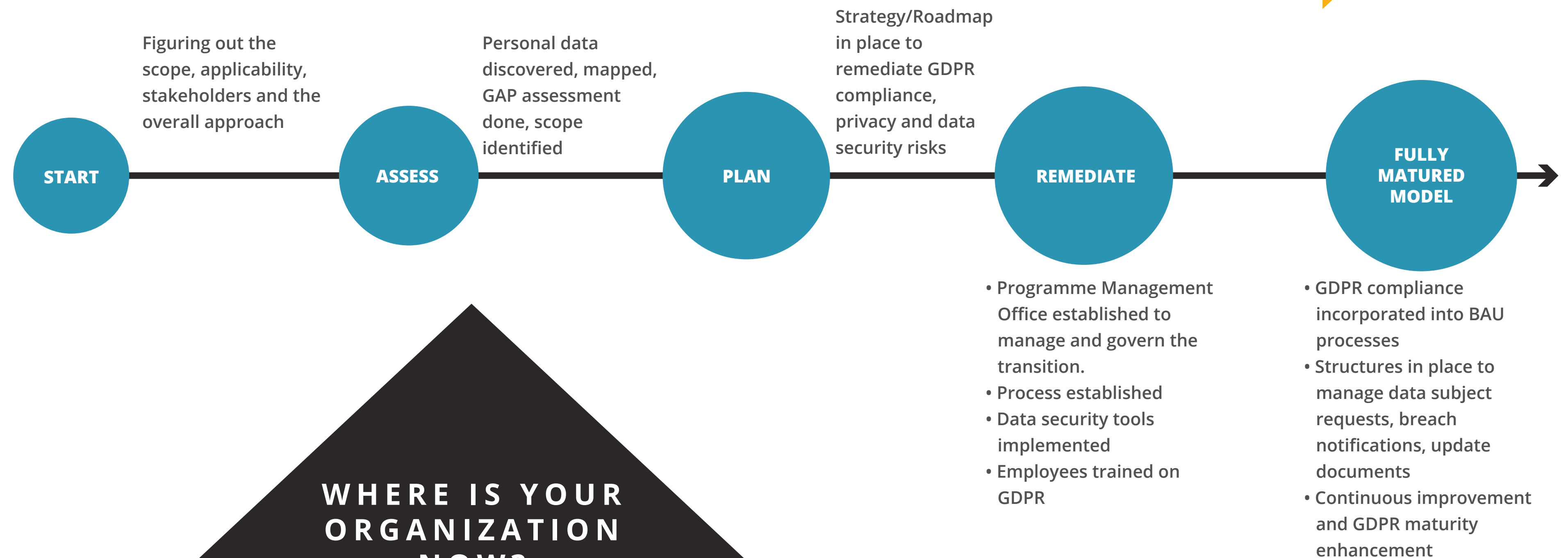

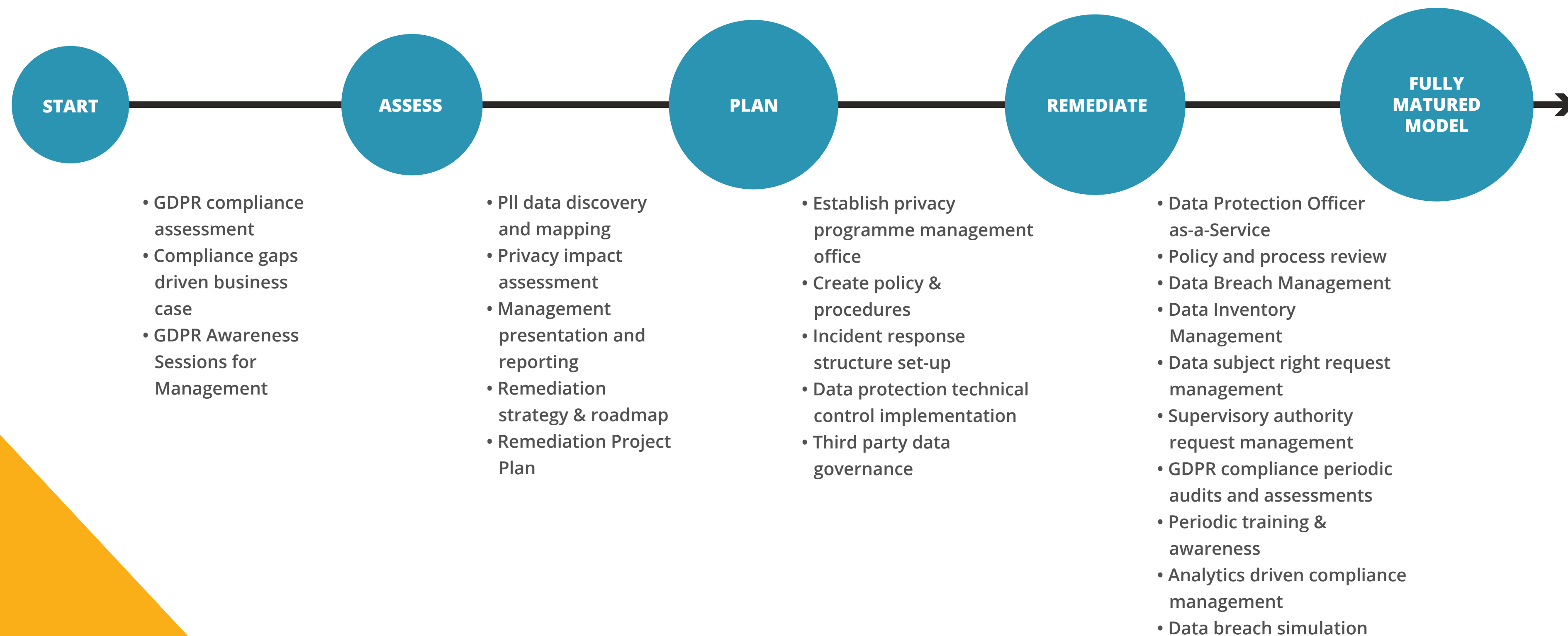
