Non-compliance could cost com-panies fines of €20m or 4% of annual global turn-over, whichever is greater. The law applies to all organizations that offer goods and services to people in the European Union (EU), or that collect and analyze personally identifiable information (PII) tied to EU residents, no matter where they are located. The GDPR also mandates Data Protection Officers (DPOs) for ensuring compliance with GDPR requirements. Considering the increasing number of data breaches in the current digital world, the negative impact of these breaches, and the associated business downtime, the GDPR does come in as a welcome humanprivacy-friendly change. But, while the GDPR helps organizations establish security-conscious transactions, how are organizations embracing the change?
