 This Statement of Audited Consolidated Financial Results for the quarter and year ended March 31, 2022 ("Audited Consolidated Financial Results") of Happiest Minds Technologies Limited (the "Holding Company" or the "Company") and its subsidiary (the Holding Company and its subsidiary together referred to as "the Group") has been reviewed by the Audit Committee and approved by the Board of Directors at their meeting held on May 05, 2022.

 The figures of the quarter ended March 31, 2022 are the balancing figures between audited figures in respect of full financial year upto March 31, 2022 and the published year-to-date figure upto December 31, 2021 being the date of the end of the third quarter of the financial year.

- 3. The Board of Directors at their meeting held on May 05, 2022 recommended a final dividend of ₹ 2/- per equity share of ₹ 2/- each for the financial year ended March 31, 2022, subject to the approval of the members at the ensuing 11th Annual General Meeting (AGM). The AGM has been scheduled on Thursday, June 30, 2022. The Register of Members of the Company will be closed from Saturday, June 25, 2022 to Thursday, June 30, 2022 (both days inclusive) for the purpose of AGM, annual closing and for determining entitlement of members for the final dividend for FY'22. The record date for payment of final dividend would be June 24, 2022 and the dividend approved by the members will be paid on and after July 05, 2022.


