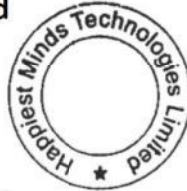

**Subject: Clarification regarding Gender-Wise Shareholder Data in Form MGT-7 Filing**

We have made every effort to ensure accurate and transparent reporting based on the information available to us through our RTA and depositories. 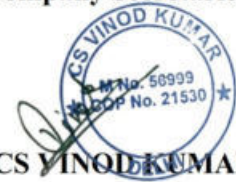
