

# CYBER RISK PROTECTION PLATFORM



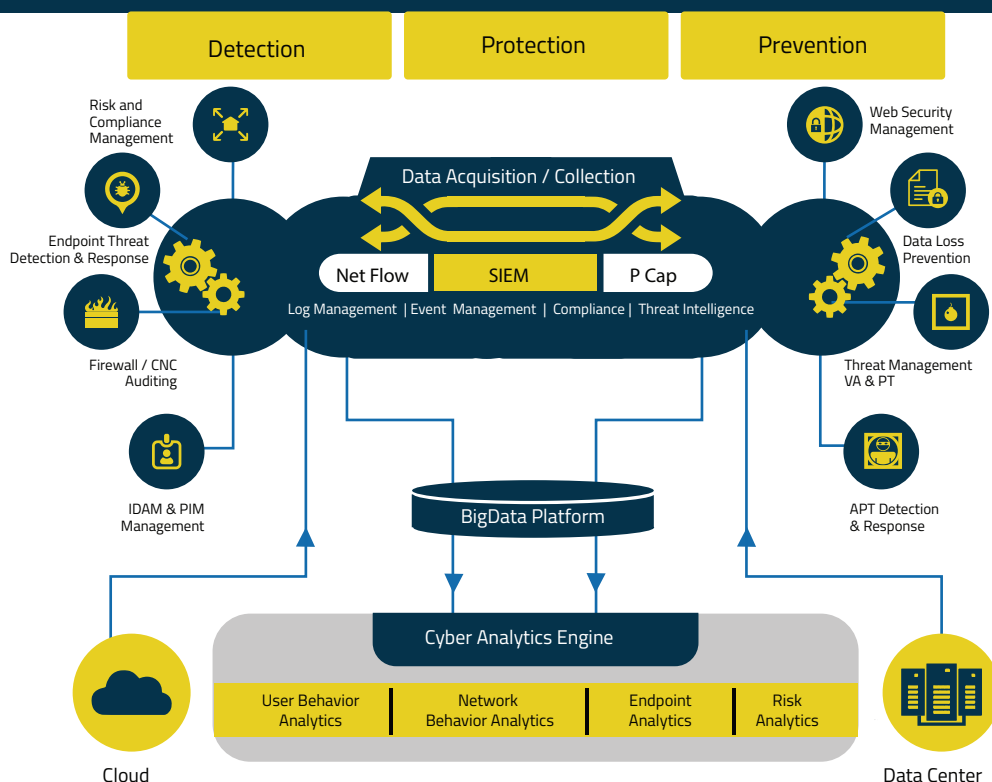
